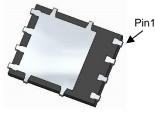

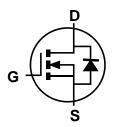

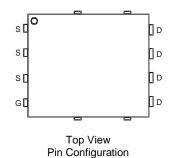








Internal Schematic

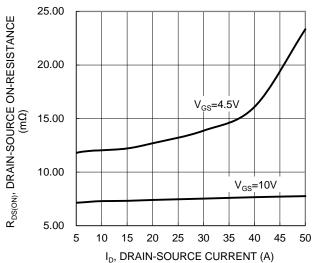
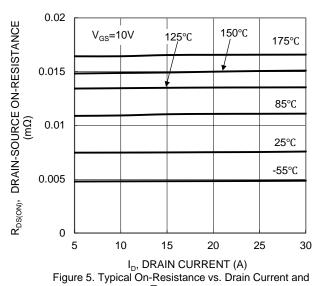
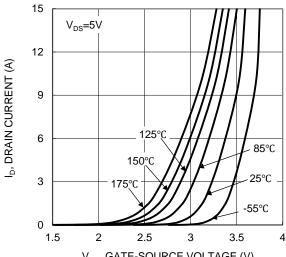


Figure 3. Typical On-Resistance vs. Drain Current and

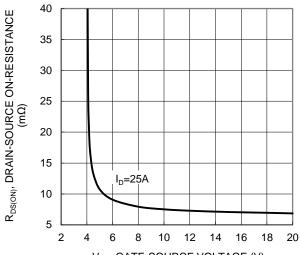

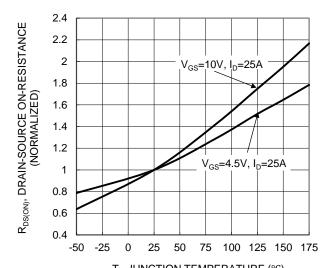

T_{J.} JUNCTION TEMPERATURE (°C) Figure 6. On-Resistance Variation with Temperature



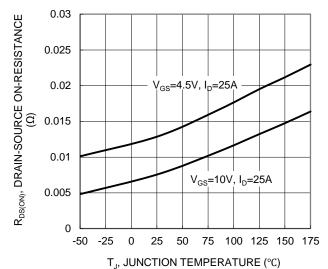


Figure 7. On-Resistance Variation with Temperature

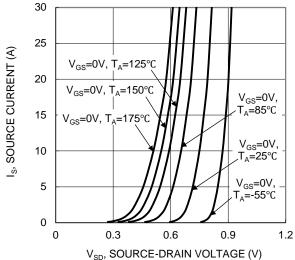
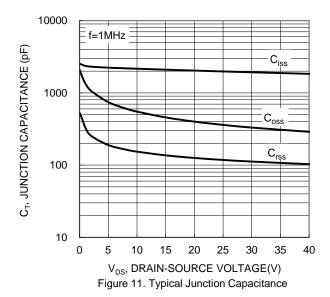


Figure 9. Diode Forward Voltage vs. Current



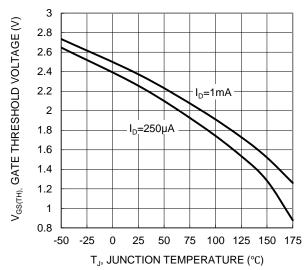
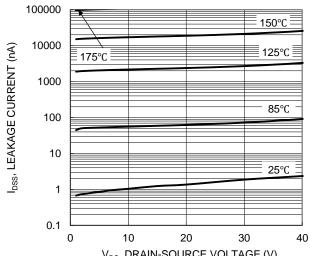


Figure 8. Gate Threshold Variation vs. Junction Temperature



V_{DS}, DRAIN-SOURCE VOLTAGE (V) Figure 10. Typical Drain-Source Leakage Current vs. Voltage

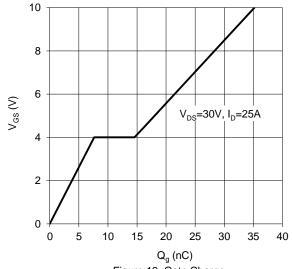


Figure 12. Gate Charge



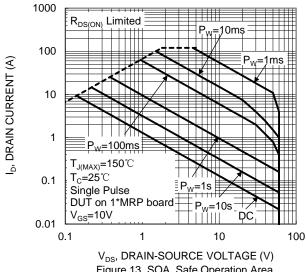
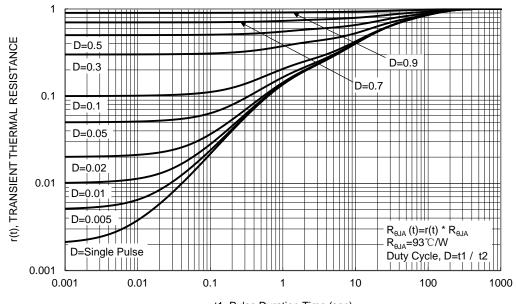


Figure 13. SOA, Safe Operation Area



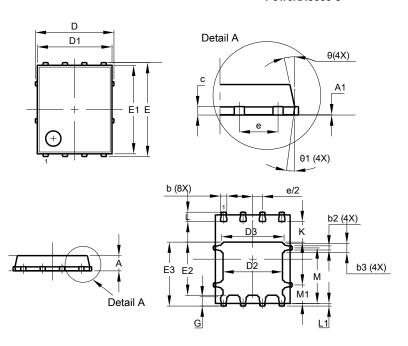
t1, Pulse Duration Time (sec) Figure 14. Transient Thermal Resistance

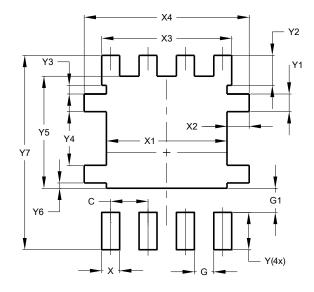
